ACE Enrollment & Female Exposure Worksheets

If you wish to participate in the ACE program in 2022, your completed female exposure and disposal sheets must be received at the Canadian Angus Association office by December 1, 2021.

Please note: enrollment for ACE is due by December 1 of the previous year. You cannot enroll in the ACE program after the current calendar year starts; you must enroll by December 1 of the prior year.

Female exposure worksheets help clear inactive females from your inventory. This is especially important for members who choose to participate in the Angus Cow Enrollment (ACE) program as ACE fees are based on the number of active cows in your herd inventory. Please note all exposure sheets are sent out via email in October. If you have not received yours, please contact registry@cdnangus.ca.

The ACE program is poised to simplify the breeder experience so members can spend less time paying bills and more time doing what matters to them. Members who join ACE pay \$65/cow which gives them access to more than 30 member services to be used within two calendar years. (Please see below for a full list of services.)

If you do not wish to enroll an animal in the ACE program, you must complete the Female Exposure and Disposal worksheet to indicate all cows that are no longer active.

Please note this form MUST be completed and returned in order for your 2022 ACE membership to be activated. Members who do not return their exposure sheets and this signed form will NOT be enrolled.
